## Redneck Relay Race Contest-

### Sunday, July 22, 2018

**Rules and regulations:**

- Teams of 2 will compete in a timed relay race, with events such as; panning for gold (eating through whipped cream to find coins), tossing ears of corn into a bucket, run a distance while balancing an egg on a spoon.
- Lassen County Fair will provide supplies to complete these games.
- The winner of the 5-10 age group will receive \$50; the winner of the 11-17 age group will receive \$100; the winner of the 18+ age group will receive \$100 .
- **Application must be submitted to the fair office by 5 p.m. Friday, July 20, 2018 – NO EXCEPTIONS**
- **Entries are limited to 20 contestants in each category.**
- All contestants must check in at the stage by Jensen Hall by **2 p.m. Sunday, July 22, 2018** or forfeit your spot in the contest
- No one is allowed to leave the designated judging area once the contest begins
- Contestants must wait for the signal to start.
- All judges' decisions will be final.
- Any contestant caught breaking any of the above rules will be disqualified.

If entering as a member of a junior organization or school, a leader or instructor's signature is required. If entering as an independent junior, parent or guardian's signature is required. The undersigned states herewith, that he/she is a recognized supervisor of the project(s) listed above; that to his/her personal and actual knowledge the statements regarding the same are true; and he/she has read and has full understanding of the rules and regulations of the Dixon May Fair and agrees to be governed by them.
