

Local Rules

All State, Local & Health Rules apply to ALL exhibitors. Please Review “State Rules for California Fairs”.

1. **Entries:**

Please see entry deadlines on each division for specific dates. All completed entry forms and fees must be in the fair office by 5PM on closing date of entry or postmarked no later than the closing dates listed for each division. **Still exhibit entry forms may be submitted late for an additional \$10 until June 22nd.**

NO EXCEPTIONS FOR LIVESTOCK.

Entries must be on an official entry form. Entry forms are available at lassencountyfair.org and in the fair office. **New to 2023** entry forms and fees may be uploaded online through ShoWorks at the above website. Exhibitors are responsible for all errors on entry forms.

2. **Removal of Exhibits:**

No exhibit shall be removed from the exhibit buildings before the release date & time. Still exhibits can be picked up the Monday following fair week from 10AM – 5PM. Entries are kept for two weeks following the fair or the fair office may dispose of them. All livestock shall be removed after 5PM on Sunday of fair week.

3. **Removal of Exhibits:**

No exhibit shall be removed from the exhibit buildings before the release date & time. Still exhibits can be picked up the Monday following fair week from 10AM – 5PM. Entries are kept for two weeks following the fair or the fair office may dispose of them. All livestock shall be removed after 5PM on Sunday of fair week.

4. **Refunds:**

Requests for refunds must be made in writing to the fair. Refunds may be granted upon review of fair management. See state rules.

5. **Placement of Ribbons:**

Ribbon placement does not guarantee official placement. Only official judging sheet constitutes the final placement.

6. **Theft & Risk:**

All entries are shown at exhibitor’s risk. Management is not responsible for any theft or loss while exhibits are on the grounds.

7. **Extended & Local Divisions:**

Extended divisions are open to the United States. Local Divisions are open to residents of Lassen, Plumas, Sierra, Modoc, Shasta, Siskiyou, Trinity & Tehama counties.

8. **All Vehicles:**

All vehicles must be removed from the barn areas to the parking lots by 8AM each day of the fair and removed from the remaining areas of the fairgrounds by 10AM. Violators will forfeit their parking pass and vehicle may be towed at owner’s expense. Horse trailer parking will be behind barn 5.

9. **Best of Show:**

A best of show ribbon may be awarded at the judge’s discretion in still exhibits for both the junior open and open divisions.

10. **No Dogs:**

No dogs will be allowed on fairgrounds except for identifiable guide dogs accompanying disabled persons and pre-entered exhibition dogs.

11. **Skateboards, Bicycles, etc.:**

Absolutely no bicycles, roller blades, skates or skateboards will be allowed on the fairgrounds.

12. **Premium Book Changes:**

All suggested changes to the premium book must be submitted to the fair office at least 12 days prior to the September Lassen County Fair Advisory Board Meeting.

13. **Judging System:**

Danish System: Compares each exhibit on its own merit against its scorecard or recognized standard and award as many 1st, 2nd, and 3rd places as merited.

American System: Ranks exhibits against one another and awards one first place, one second place, etc.

14. **Susanville Fire Department:**

Each booth and barn will be inspected regarding fire hazards. All materials must be non-flammable or treated with fire retardant.
