

# Entering Exhibits, Exhibitor Passes, & State Rules

All State, Local & Health Rules apply to ALL exhibitors.  
Please Review "State Rules for California Fairs".

## State Rules

## Exhibitor Passes

1. All livestock & still exhibitor passes must be purchased at the time of entry form submission, this includes parking passes.
2. All livestock passes will be picked up following the livestock exhibitor meeting at 2PM on Tuesday of fair week. Passes will not be sole in the livestock office or at the livestock gate. Still & horse exhibitor passes will be distributed at time of purchase.
3. Passes are purchased as follows:
  - a. **Still Exhibits:**
    - 1 exhibitor pass per exhibitor (\$5)
  - b. **Livestock Exhibits:**
    - 1 livestock pass per exhibitor (\$5)
    - 1 free parking pass per family
    - 1 additional parking pass per family (\$5)
  - c. **Horse Show:**
    - 1 exhibitor pass per exhibitor (\$5)
    - 1 free parking pass per family
    - 1 additional parking pass per family (\$5)
    - Weeklong stall rate \$25
    - One night stall rate \$15
    - Weeklong tack rate \$20
    - One night tack rate \$10

## How to Enter

1. Find the division and classes you wish to enter in the Premium Book. Fill out your entry form completely. Have entry forms filled out before bringing it to the fair office. Fair staff is not allowed to fill out entries for you or take them over the phone. Double check division and class numbers. All errors on entry forms are the responsibility of the exhibitor.
2. Read all local and state rules.
3. Entry forms are now able to be submitted online by visiting [www.lassencountyfair.org](http://www.lassencountyfair.org). Entry forms may also be mailed or dropped off at the Lassen County Fair Office at 195 Russell Avenue, Susanville, CA 96130. Check all entry deadlines for each division and class. **LATE ENTRIES WILL ONLY BE ACCEPTED FOR STILL EXHIBITS.** Still exhibit late entries will be accepted until June 22<sup>nd</sup> with an added \$10 late fee. **NO LATE ENTRIES FOR LIVESTOCK EXHIBITS.**
4. Entry forms for 4-H, FFA, Grange and Independent exhibitors must be signed by the project leader and parent/guardian before they will be accepted in the fair office.
5. Bring your articles to Jensen Hall at the Lassen County Fairgrounds on the date and time specified for each individual division and class.
6. A pre-printed exhibit tag will be provided for each still exhibit.
7. The exhibit will remain on display until 10AM the Monday following the fair.
8. Entries not claimed within two weeks following the fair will be disposed of at the fair's discretion.
9. Premiums will be paid 10 days after the fair ends. All checks must be picked up at the fair office unless exhibitor lives 75 miles or over outside of Susanville, CA. These checks will be mailed to exhibitors. Checks not cashed by November 30<sup>th</sup> will be voided and forfeited to the fair.
